I. CALL TO ORDER

John called the regular meeting to order at 3:57 p.m. at the Riverview Cemetery Mausoleum, Minturn, CO.

IV. <u>APPROVAL OF MEETING MINUTES</u>

John motioned to approve the meeting minutes from the May 9, 2023 regular meeting, Stephen seconded, and all were in favor.

V. DISCUSSION

A. Shed Building Site Plan Revisions:

Pedro from Zehren & Associates attended the meeting to provide a Town of Minturn shed building project application update to the board and staff members. Pedro met with Town staff, Madison and Scot. Pedro explained the cemetery operations importance of the practical, functional shed building to cemetery winter burial operations and other maintenance tasks throughout the seasons.

Additional comments from Town of Minturn staff include "work within space within property boundaries and do not encroach on BLM land to complete the project

work". Also, a dark-sky compliant light at the man-door is required as well as an up-to-date survey of the property (must be within 6 months of the application). Pedro will get moving on this to keep the application moving forward through planning and zoning board review and Council review. He will let us know when the project plans to go before the Minturn Town Council.

B. Old Edwards Cemetery Update:

Josh McMahon, the attorney that the District has hired for quiet-title services provided an action plan for moving forward. The heirs of Ora Jane Forgey have been identified with about one third (24 people) of those heirs having left the direct blood line.

Josh doesn't believe the Cemetery District has an adverse possession claim and will move forward with attempting to get at least one deed with the idea that the judge would grant a patrician action for the property via foreclosure sales.

Next steps will be Josh working directly with Dena Darst, Ancestry Pro Genealogists:

- 1. Finalize Ronald Reeves deed
- 2. Listing of heirs and addresses for notifying
- 3. Draft a summary report to notify heirs

C. Minturn Cemetery District Board of Directors Nomination

The Minturn Cemetery District has an upcoming Board of Directors vacancy for board member, John Sheehan. The six-year term is to commence on July 28, 2023. John Sheehan, BOD President, has served for many years and would like to continue his service.

Stephen motioned to recommend John to the Board of County Commissioners as the candidate for board appointment to commence on July 28, 2023 for a six-year term. Art seconded and all were in favor.

D. Property Report:

Ray presented a tree landscaping bid for the upper cemetery. John motioned to approve the Fitz bid for \$19829.20. Stephen seconded and all were in favor. Staff will mover forward with scheduling the plantings this season.
